ORDER

1. As per paper read(1) above, Scheme, Syllabus and Model Question Papers of New Generation Programme B A Social Science-Economics (CBCSS-OBE), were implemented at Mary Matha Arts & Science College, Mananthavady w.e.f 2021 admission.
2. As per paper read (2) above, Single Window Cell pointed out that the Eligibility Criteria and Index Mark Calculation for admission to the aforementioned programme are not given in its scheme and Syllabus and hence requested clarification in this regard.
3. As all activities of the reconstituted Boards of Studies are kept in abeyance in the light of judgement in WA No.1530/2021 dated 22.03.2022, the Convener of Expert Committee which prepared the above syllabus, was requested to submit the Eligibility Criteria and Index Mark Calculation for admission to B A Social Sciences-Economics programme CBCSS-OBE as per paper read(3) above.
4. As per paper read(4), the Convener, Expert committee submitted Eligibility Criteria and Index Mark Calculation for admission of B A Social Science -Economics Programme as detailed below;
Eligibility for admission to BA Social Sciences -Economics Programme- A pass in Higher Secondary Examination of the state or an Examination accepted by the University as equivalent thereto.
Calculation of index- Total marks of the qualifying examination + 50 Marks for candidates who studied Economics
5. The Vice Chancellor, after considering the matter in detail, and in exercise of the powers of the Academic Council, as per section 11(1), Chapter III of Kannur University Act, 1966 has accorded sanction to implement Eligibility criteria and Index Mark Calculation as detailed in para(4) for admission to New Generation programme B A Social Science Economics CBCSS-OBE, at Mary Matha Arts & Science College, Mananthavady, w.e.f 2022 admission.
6. The U.O read(1) above, stands modified to this extent.
