**ORDER**

1. As per paper read (1) & (2) above the Scheme, Syllabus and Model Question papers of the B.Sc. Forestry programme and B.Sc. Botany Programme respectively, were implemented in affiliated colleges w.e.f 2019 admission
2. In the Scheme of Forestry, maximum mark for Complementary Elective Course Botany is 40 (32+8) where as in the syllabus of Botany it is 50 (40+10).
3. The Examination Branch, as per paper read (3 ) above, requested to clarify the anomaly in maximum marks for Complementary course Botany in Forestry
4. The Board of Studies in Forestry(Cd), vide paper read (4) above, recommended to modify the maximum marks of Complementary Elective Course Botany in Forestry as 50 (40+10) and to distribute the 50 marks for complementary course Botany as 40 marks for theory (External Examination) and 10 marks for Internal Evaluation.
5. The Vice Chancellor, after examining the matter in detail, and in exercise of the powers of the Academic Council as per section 11(1), Chapter III of Kannur University Act 1996 and all other enabling provisions read together with, has accorded sanction ***to implement the aforesaid modifications detailed in para (4) in the Scheme and Syllabus of B.Sc. Forestry programme under CBCSS (OBE) with effect from 2019 admission***, subject to reporting to the Academic Council.
