**ORDER**

1. The XXIX<sup>th</sup> meeting of the Academic Council, held on 21/12/2024 vide paper read 2, considered the request of a 2005 admission student to conduct Mercy Chance Examination for Afzal UI Ulama preliminary (SDE) Part-II English (old syllabus) and approved the same.
2. Subsequently, the Examination Branch vide paper read (3), requested to issue University Orders in this regard
3. Considering the matter, the Vice Chancellor has ordered to place the matter of fixing the re-registration fee and course wise fee to be levied from candidates for the conduct of mercy chance examinations, before the consideration of the Syndicate.
4. Subsequently, the meeting of the Syndicate held on 05/05/2025 vide paper read 4, resolved to fix Rs.5,000/- (Rupees Five Thousand only) as re-registration fee and Rs.1,000/- (Rupees One Thousand Only) as course fee per paper.
5. The aforementioned Resolution of the Syndicate has been implemented.
6. Therefore, in view of the resolution of the Academic Council (vide paper read 2) and resolution of the Syndicate (vide paper read 4), which are implemented in the University, **sanction has been accorded to conduct one time Mercy Chance Examinations for Part II English papers of Afzal UI Ulama (preliminary) ( SDE ) (old syllabus up to 2010 admission) programme by levying Rs.5000/- (Rupees five thousand only) as re-registration fee and Rs.1000/- (rupees One thousand only) as fee for each paper.**
7. The Examination Branch shall initiate further steps to notify the Examinations accordingly.
