## NOTIFICATION

It is notified that the following Amendments in Chapter IV – TERMS AND CONDITIONS OF SERVICE OF THE NON- TEACHING STAFF OF THE UNIVERSITY- Part II – Statute 22A- Posting of employees on transfer from other Universities - Statute 22A(Viii) of Kannur University First Statutes 1998 passed by the Syndicate at its meetings held on 22/08/2024 has been assented to by the Chancellor on 06/04/2025.

The amendments to Statutes shall be deemed to have come in to force with effect from 06.04.2025

Amendments to Kannur University First Statutes 1998 – Chapter IV- TERMS AND CONDITIONS OF SERVICE OF THE NON- TEACHING STAFF OF THE UNIVERSITY - Part II - Statute 22A - Posting of employees on transfer from other Universities- Statute22A (Viii)

That, the existing provision Kannur University First Statutes 1998 – Chapter IV – Part II – Statute 22A- Posting of employees on transfer from other Universities-22A (Viii) is amended as follow

22A(Viii). The University from which such employees are transferred shall pay the leave salary and pension contribution of such employees to the University when they are transferred	Omitted	Omitted	<ol style="list-style-type: none"> <li>1. In case of inter University transfer of employees allowed, the payment of leave salary and pension contribution ( both accepting and remitting)is not insisted so far as the transfer is allowed on reciprocal basis</li> <li>2. As per G.O.(P) No. 517/09/Fin dated:19.11.2009, the payment of pro-rata pensionary liabilities by the former employer while reckoning the service put in by government in the Panchayath/Municipal Common Service and Universities prior to their entry in State Government service and vice-versa was dispensed with</li> <li>3. As per Government order G.O(P)No.576/2012/Fin dated:16.10.2012 the Government have ordered that no payment of pension contribution to Government will be effected in respect of Government servants transferred on deputation to institutions without any source of income to meet salary expenditure except grant-in-aid released by the State Government and Government have informed</li> </ol>
