NOTIFICATION

It is notified that the following amendments to Statute 25, 37 and 45 of Chapter II of the Kannur University First Statutes 1998 passed by the Syndicate at its meeting held on 08.06.2020 has been assented to by the Chancellor on 30.09.2020.

These amendments to statute shall be deemed to have come into force with effect from 30.09.2020.

Amendment to statute 25, 37 and 45 of CHAPTER II – ‘Officers of the University’ of the Kannur University First Statutes, 1998.

That, the existing provision in statute 25, 37 and 45 of Chapter II - (**The Registrar - Statute 25- ‘Age of retirement’, Controller of Examinations – Statute 37- ‘Superannuation’ and The Finance Officer – statute 45 – ‘Superannuation’,** is amended as follows.
