I. ESSENTIAL QUALIFICATIONS

As per 'University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations 2018' (UGC Regulations 2018 in short) and subsequent amendments, if any. NCTE Norms will also be applicable to the post of Assistant Professor in the Department of Pedagogical Sciences.

II GENERAL INSTRUCTIONS

1. Ph.D. Degree is preferable for appointment of Assistant Professor.
2. A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.
3. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the

candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (non-creamy layer)/Differently Abled ((a) Blindness and low vision; (b) Deaf and Hard of hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy; (d) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed), wherever specified, and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

4. A relaxation of 5% will be provided (from 55% to 50% of the marks) to the PhD Degree holders, who have obtained their Master's Degree prior to 19 September, 1991.
5. The time taken by candidates to acquire M.Phil. and/or Ph.D. Degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing research degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment/promotion.
6. A relevant grade which is regarded as equivalent to 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid. The candidate must submit a certificate of conversion of Grade to Percentage issued by the concerned Degree awarding University.
7. Candidates claiming previous service / experience should submit certificate fulfilling the conditions as per Clause 10 of UGC Regulations, 2018.
8. Research Publications will be considered subject to the conditions specified in the UGC Public Notice No.F1-1/2018(Journal/CARE) dated 16.09.2019.
9. Candidates possessing foreign degrees should upload an Equivalency Certificate issued by the Association of Indian Universities (AIU) along with their respective degree certificate and the same shall be produced during the physical verification of original documents.
10. The teachers appointed may be assigned with academic or administrative responsibilities in addition to their regular teaching and research activities.
11. Any errors or omissions detected in the Advertisement and the process of selection are subject to rectification by the University.
12. Please refer to UGC Regulations 2018 and its amendments from time to time / NCTE norms for any further clarifications wherever applicable.
13. Applicants will be solely responsible for the authenticity of the information submitted. All the information/addendum/corrigendum etc subsequent to this Advertisement, if any, will be uploaded in the University website only. Candidates are advised to regularly check the University website for updates. The university will not be held responsible for any information which is unnoticed by the candidates.
14. All correspondence from the University, including intimation for the interview, will be sent only to the e-mail address provided in the online application. University will not be responsible for any inadvertent/technical errors occurred during the mail delivery.

15. All papers/Research publications, etc. claimed by the applicant should be uploaded in MS Word or text searchable PDF formats (not scanned or images) - which usually means that text can be selected, copied and pasted with the cursor. Documents provided through 'Google Drive' should be made available with the sharing option "*anyone with the link*" till the interview for the post is over.
16. Applicants should possess the prescribed qualifications and experience on the date of submission of application for the respective posts. Publications 'under submission' or 'submitted to referees' will not be considered.
17. The posts notified carry UGC pay scales with admissible allowances as approved by the Government of Kerala from time to time.
18. Mere fulfillment of the qualification or the eligibility criteria does not entitle an applicant to be necessarily considered for interview. Applications received will be screened in accordance with the provisions of UGC Regulations 2018, NCTE norms and other rules applicable to Kannur University, by a committee constituted in this regard. The shortlists will be published only on the official website of the University. Only those candidates shortlisted by the University will be called for an interview.
19. Candidates securing a total Academic/Research score of **75** and above (for the post of Associate Professors) and **120** and above (for the post of Professor), as per Appendix- II, Table 2 of UGC Regulations, 2018 will only be considered for the respective posts. The University may, at its discretion, restrict the number of candidates to a reasonable limit based on the number of vacancies and number of candidates securing the specified scores. This will be on the basis of higher scores received in the screening. In case of any dispute with regard to screening of the applications, the decision of the Screening Committee will be final.
20. Applicants must upload necessary documents issued by a competent authority in support of their claims. Failure to do so may result in rejection of their applications without further notice and no appeal against such rejections will be entertained.
21. Consequent upon adoption of self-certification provisions, the University will process the applications on the basis of information furnished and documents uploaded in the application. If the information/documents are found to be false/ incorrect by way of omission or commission, the responsibility shall lie solely with the applicant and the applicant may face legal actions.
22. Applications which do not meet the eligibility criteria given in this notification and / or are incomplete in any respect will be summarily rejected. Furnishing false, tampered or fabricated information or suppressing any material/information in the application will be punishable as per the laws applicable in this regard.
23. In case the applicant gets screened/shortlisted/selected/appointed, as the case may be, on the basis of the credentials furnished by the applicant, which are, on scrutiny, found to be incorrect/inadmissible/forged/fabricated/falsified, the applicant's candidature will be cancelled at any stage of the recruitment/at any time during the tenure of the service and appropriate legal action will be initiated.
24. The University will verify the antecedents of the applicant at the time of appointment or anytime during the tenure of the service. In case it is found that the documents/information submitted by the candidate is false or the candidate has suppressed any relevant information, the service of the candidate shall be terminated without prejudice to any other action initiated by the University.

25. The University reserves the right to modify/withdraw/cancel any communication made to the applicant. In case of any dispute arising out of such a situation, the decision of the University will be final.
26. The candidates called for the interview have to report along with all the testimonials/ certificates in original along with a valid photo Identity Card. If the University chooses to conduct interviews in online mode, provisional ranked lists will be published and appointments will be offered only after the physical verification of the original documents.
27. Applicants serving in Government/ Public Sector Undertakings (including Boards/ Universities/Autonomous Bodies etc.) are required to upload '**No Objection Certificate**' from the employer and the same shall be produced during the physical verification of original documents.
28. The University reserves the right to change/alter the number of posts or decide not to fill any of the posts mentioned in the advertisement at its discretion without assigning any reason thereof.
29. In case of any inadvertent mistakes in the process of selection, which may be detected at any stage even after the issuance of offer letter, the University reserves the right to modify/withdraw/cancel any communication to the applicants.
30. In case of any dispute/ambiguity arising in the process of selection, the decision of the University will be final.
31. No TA/DA will be paid to candidates for attending the interview.
32. Canvassing, in any form, will be treated as a disqualification.
33. Any disputes/suites/legal proceedings in connection with this notification will fall only under the jurisdiction of the Hon'ble High Court of Kerala.
34. Maximum Age limit is 50 years (as on 01/01/2024) for the post of Assistant Professor (Usual age relaxation of upper age limit will be given to eligible categories as per relevant rules applicable). There is no upper age limit for applicants to the posts of Professor and Associate Professor, provided, they should be below the age of retirement for teachers in Kannur University at the time of joining duty.
35. The G.O.(P) No.135/2014/Fin dated 08/04/2014 (regarding National Pension System) & G.O.(P) No.211/2005/Fin dated 11/05/2005 (In the case of officiating appointments from a higher time scale of pay to a lower time scale of pay, by direct recruitment, the Officer's officiating pay in the lower time scale shall be fixed at the minimum of the scale of pay of the new post without considering his pay in the higher time scale except in the cases where such appointments are made in accordance with the Special Rules) will be applicable to the appointments.
36. The appointment will be subject to the Provisions of Kannur University Act, Statutes, Ordinances & other relevant rules applicable to the University.
