NOTIFICATION

It is notified that the following Amendments in Chapter XLVII – CONDITIONS OF SERVICE OF TEACHERS AND MEMBERS OF NON-TEACHING STAFF IN PRIVATE COLLEGES of Kannur University First Statutes, 1998 by replacing existing Statute 14 with new Statute 14 passed by the Syndicate at its meetings held on 14.02.2025 has been assented to by the Chancellor on 10.04.2026. The amendments to Kannur University First Statutes, 1998 shall be deemed to have come into force with effect from 11.04.2023.

Amendments to Kannur University First Statutes 1998 – Chapter XLVII – CONDITIONS OF SERVICE OF TEACHERS AND MEMBERS OF NON-TEACHING STAFF IN PRIVATE COLLEGES - PART B - CONDITIONS OF SERVICE OF TEACHERS IN PRIVATE COLLEGES

That, new Statutes in Chapter XLVII, PART B (CONDITIONS OF SERVICE OF TEACHERS IN PRIVATE COLLEGES), by replacing Statute 14 with a new Statute 14, is amended as follows:

Chapter : XLVII – PART B Kannur University First Statutes, 1998. **(CONDITIONS OF SERVICE OF TEACHERS IN PRIVATE COLLEGES)**

Existing Statute	Statute after amendment
<u>Chapter XLVII Part B</u> 14. Age limits for direct appointment- The Minimum age limit and the maximum age limit for appointment by direct recruitment of Lecturers in a Private Arts and Science college shall be 18 (Eighteen) and 36 (Thirty Six) respectively as on the first day of July of the year in which applications for appointment are invited with the usual relaxation of age limits to members of SC/ST/OBC Communities as in the Government Services. "Whereas in the case of direct recruitment of Lecturers in Private Training Colleges the maximum age limit shall be the same as fixed from time to time by the Government for direct recruitment of Lecturers to Government Training Colleges". Provided that the upper age limit shall be relaxable by five years, in the case of persons who are in service as teachers in Private Aided High Schools or Government High Schools, for appointment as Lecturers in Private Arts and Science Colleges.	<u>Chapter XLVII Part B</u> 14. Age limits for direct appointment-The minimum and maximum age limits for appointments by direct recruitment of teachers in Private Arts and Science Colleges, Arabic Colleges and Private Training Colleges shall be same as those applicable from time to time for direct recruitment of teachers in Government Colleges.
