**I. Background:**

The Kannur University invites re-expression of interest (Re-EOI) from Sewage Treatment plant design Consultancy firms to participate in Planning, Design and Preparation of detailed estimate for implementing new STP for Thavakkara Campus. Kannur University(KU) is a multi campus public university to serve region of north Malabar in the State of Kerala

KU is planning to establish new Sewage Treatment Plant by assessing the requirement of the campus.

There will be a two stage competition where the participated agencies' capabilities will be evaluated based on the eligibility criteria and the qualified agencies will be requested to send commercial quotations.

**II. Eligibility Criteria:**

**a. Registration-** The applicant shall be a company/ partnership / LLP firm registered in India under relevant Act as may be applicable (e.g. Indian Companies Act, 1956/2013; the Partnership Act, 1932 and who have their registered office in India.

**b. Experience-**The Consultancy should have at least 10 years of experience in overall and a minimum of 5 years 'experience working on similar assignments with academic institutions and allied institutions as on 30.06.2026.

**c. Past Assignment-** The Consultancy Firm must have at least completed project handled in the past equivalent to or above a budget of Rs 50 lakhs in the last three years. KU will demand for the proof of work completion certificate as applicable.

**d. Professional Fees-** Applicant should have collected Professional fees of at least Rs. 5 Lakhs per year in the last three financial years.

**e. Declaration for Transparency-** Applicant should not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Govt. of India/ State Govt. (Please submit self-declaration format as per Annexure)

**III. Scope of the Work:**



Thavakkara Campus has a total land area of 13.74 acres, featuring lush green vegetation and a water storage pond. The campus comprises several buildings, including the Administrative Block, Students' Amenity Centre, Central Library, MMTC, and Seminar Complex (currently under construction).

The total staff strength at the campus is approximately 600 personnel. In addition, around 100 visitors and other external stakeholders visit the campus daily for various purposes.
