**ORDER**

1. As per the the papers read as (i) to (iii) above, the Recommendations of the Boards of Studies regarding the Recognition/Equivalence of Degrees of other Universities/ Institutions were placed before the consideration of the meeting of the Standing Committee of the Academic Council.
2. The meeting of the Standing Committee of the Academic Council, held on 07.10.2024, vide the paper read as (iv) above, considered the matter of Recognition of Degrees of other Universities and resolved to recognize the following Degrees awarded by other Universities, as detailed below.

3. Further, the Standing Committee of the Academic Council considered the matter of Recognition of other Degrees also and recommended the following.

- i). **Not to recognize** B.A. Economics, Political Science, Sociology (Triple Main Regular) Degree of St. Aloysius College (Autonomous) under Mangalore University, Karnataka, as equivalent to B.A. Political Science degree of Kannur University as suggested by the Board of Studies in Political Science (combined).
- ii). **Not to recognize** Shastri (B A Sanskritam (Sahityam)) Degree of Central Sanskrit University, New Delhi (pursued from Calicut Adarsh Sanskrit Vidyapeeth, Balussery), as equivalent to B.A. Sanskrit Degree of Kannur University as suggested by the Board of Studies in Sanskrit (combined).

4. After considering the matter in detail, the Vice Chancellor, exercising the powers of the Academic Council conferred as per the Section 11(1), Chapter III of Kannur University Act, 1996, approved the aforesaid Recommendations of the meeting of the Standing Committee of the Academic Council held on 07.10.2024 (item No. 15, 23 & 24) and accorded sanction to recognize the two aforesaid Degrees awarded by Amrita Vishwa Vidyapeetham (Deemed to be University), Coimbatore and Chandigarh University, Punjab, as detailed in the table above and also approved the Recommendation of Standing Committee of the Academic Council, as detailed in Para 3 above, subject to reporting to the Academic Council.


