## ORDER

- 1. The Regulations, Scheme & Syllabus of Three Year LLB Programme at the Department of Legal Studies, Manjeswaram Campus of the University were implemented w e f 2022 admission vide the paper read (1) above.
- 2. As per the approved Regulations, all Practical courses in third, fourth, fifth and sixth Semester have only Internal component, whereas, as per the Scheme, the Written Examination (WE) mark is included for the first four Practical papers. The Examination Branch pointed out this error vide paper read (2) and subsequently, clarification was sought in this regard from the Head, Department of Legal Studies.
- 3. Following this, the Head, Department of Legal Studies, vide paper read 5, intimated that the Department Council discussed the matter and resolved to correct the above mentioned error and avoided the Written Examination Marks, assigned to this Course and 100 Mark is given as Internal Component.
- 4. Further, the Examination Branch pointed out some some other discrepancies in the Scheme and Syllabus part, vide papers read as 3 & 4 and subsequently, the Department Council corrected the following errors pointed out by the Examination Branch.
- i.The name of the Paper of 3CP22 in V semester has been corrected as 'Law of Direct Taxation' instead of 'Law of District Taxation' in the Syllabus.
- ii. The name of the Paper of 6PT03 in V th Semester has been corrected as 'Alternative Dispute Resolution' instead of 'Alternate Dispute Resolution' appeared both in the Scheme & Syllabus part.
- iii. The name of the paper of 4CP14 in III Semester has been corrected as 'Law of Criminal Procedure I (including Juvenile Justice and Probation of Offenders Act)' in the Scheme part.
- iv. The name of the Paper of 5CP19 in IV Semester has been corrected as 'Law of Criminal Procedure II' (including Criminal Rules of Practice) in the Scheme part.
- 5. After considering the matter in detail, the Vice Chancellor ordered vide paper read 6 to place this matter before the Standing Committee of Academic Council, along with the Remarks of the Board of Studies (BoS).
- 6. Accordingly, the meeting of BoS in Law (Combined), held on 05.09.2024 vide paper read 7, considered the matter and the BoS unanimously recommend to approve the corrections made by the Department Council on the errors pointed by the Examination Branch.

- 7. Subsequently, the Meeting of the Standing Committee of the Academic Council held on 07.10.2024, vide paper read 8, considered the Minutes of the meeting of BoS in Law and recommended to approve the same.
- 8.After considering the recommendation of the Standing Committee of the Academic Council and in exercise of the powers of Academic Council conferred under the Section 11(1), Chapter III of Kannur University act 1996, the Vice Chancellor approved the Recommendations of the Board of Studies and accorded sanction to rectify the errors in the approved Scheme and Syllabus of Three Year LLB Programme implemented at the Department of Legal Studies, Manjeswaram Campus of the University w.e.f.2022 admission.
- 9. Therefore, the following Erratum is issued in this regard.
- (i) The Written examination marks, assigned to the Practical Courses 6PT01, 6PT02,6PT03 & 6PT04 in third to sixth Semesters of the LLB (Three Year Programme) is avoided and 100 Marks as a whole, is assigned as the Internal component.
- (ii) The name of the Paper: 3CP22 of the V semester has been corrected as 'Law of Direct Taxation,' instead of Law of District Taxation in detailed syllabus.
- (iii)The name of the Paper: 6PT03 of the V th Semester has been corrected as 'Alternative Dispute Resolution,' instead of Alternate Dispute Resolution both in scheme & syllabus part.
- (iv) The name of the Paper: 4CP14 of the III Semester has been corrected as, 'Law of Criminal Procedure I (including Juvenile Justice and Probation of Offenders Act)' in the Scheme part.
- The name of the Paper: 5CP19 of the IV semester has been corrected as, 'Law of Criminal Procedure II (including Criminal Rules of Practice)' in the Scheme part.
