ORDER

1. University orders were issued ,vide paper read (1), sanctioning University Junior Research Fellowship to 80 full time research scholars @ Rs.5,000/- (Rupees Five Thousand only) per month for the period upto 31.03.2017 and thereafter @ Rs.10,000/- (Rupees Ten Thousand only) per month w.e.f 01.04.2017 subject to the condition that the research fellows are not permitted to accept any assignment , paid or unpaid during the tenure of award of University Junior Research Fellowship.

2. Smt. Anjali Raj, FT R. Scholar in Malayalam, intimated vide paper read (2) that she had submitted formal application for granting University JRF on 22.10.2020 at the centre and that since she is not seen included in the order read (1) requested to consider her for the grant of University JRF during this year itself.

3. Smt. Divya Sant, FT R. Scholar in Chemistry had submitted request for grant of Uty JRF during the financial year 2019 - 20 after the closing date for submission of formal application for the same. Since the application was rejected as belated, the scholar and her R. Supervisor submitted an appeal before the Vice Chancellor and Vice Chancellor, considering the same ordered to consider her application during the next financial year subject to availability of funds. Based on the direction of the Vice Chancellor, Smt. Divya Sant submitted application vide paper read (3) with a request to consider her for Uty JRF since she is in the third year of her research and that she wish to submit her thesis within the permitted period.

4. The Research Supervisor and Head of the Research Centre of both the Scholars have certified that the scholars are not availing any other scholarship or financial assistance.

5. Considering the requests of the two scholars as a special case, Vice Chancellor has accorded sanction to grant University Junior Research Fellowship to Smt. Anjali Raj, FT R. Scholar in Malayalam and Smt. Divya Sant, F.T. Research Scholar in chemistry for a period of three years @ Rs. 10,000/- (Rupees ten thousand only)per month.


